Roles, Responsibilities, Policy and Legislation

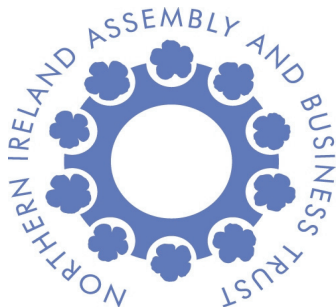

Skills, Training and Employment - Issues Raised at Speaker's Dinner

Main Issues on Skills

- Literacy and numeracy.
- High numbers of people neither in employment, education or training – social issues can be left behind.
- Dependence on migrant workers.
- Push from schools into FE and HE instead of into jobs and apprenticeships.

Gaps in Programme for Government (PfG)

- Low Awareness of PfG.
- Need for professional careers advice for GCSE pupils.
- Expansion of conversion courses to match graduates to employers.
- Abolish fees for STEM subjects.
- Address the Protestant Diaspora.
- More flexible apprenticeships allowing for a mix of college and work placements.
- Expansion of adult apprenticeships.
- Address the GB/Ni wage differential.
- In relation to RPA, a realistic strategy for re-training and re-skilling.

Programme for Government:

- Good focus on the economy but not very realistic.
- Too much focus on FDI.
- Need to look to our own workforce and the economically inactive.
- High value jobs are not within reach of economically inactive.
- Benefits trap preventing many from working – need to look at other examples of attracting people into work i.e. don't cut benefits look at incentives e.g. phased benefit loss up to first pay rise.

What does the business sector expect of the Assembly?

To build relationships with business in order to fulfil aspirations in programme for the government.

Key issues facing business in future?

- Increased productivity.
- Wage differentials.
- Training costs.
