European Research Area

- Key issues
- Fragmentation and overlaps between national research and innovation systems
- **Huge complexity** of support system with myriad of funding schemes with different rules and timetables
- Key measure
- European Research Area framework (2012) to remove cross-border obstacles by 2014
- Including coherence of overall support system





Globalisation of knowledge

- → Develop world-class excellence
- → Attract investment through better support and framework conditions
- → Establish strategic cooperation with world partners





What is the Seventh Framework Programme?

- **2007 2013**
- €50b+ in competitive funding, requires co-operation
- 27 member states + 8 associated countries + 3rd countries
- Irish target to win €600M in funding from the programme.
 (This 1.25%, we are currently at 1.3%)





Why partner with Ireland, why do research there?

- Research Impact (measured by citations)
 - ◆ 1st in the world in molecular genetics and genomics
 - ◆ 3rd in the world in Immunology
 - 3rd in the world in cholera research
 - ◆ 4th in the world in parasitology
 - 5th in the world in rheumatoid arthritis research
 - 6th in the world for Nanosciences
 - 6th in the world in molecular biology and genetics
 - 6th in the world in probiotics
 - 8th in the world Material sciences
 - Etc.





How we are organised in Ireland for FP7

- Co-ordinated by Enterprise Ireland (on behalf of government) The National Support Network for FP7 provides "hands-on" support covering all stages in the project lifecycle
- 11 organisations provide services to the network























How we are organised in Ireland for FP7

- National Delegates and National Contact Points for all areas of FP7
- Monthly national meeting of all NCPs
- Cross thematic information days
- Free training events on proposal writing, contract negotiation, project management
- Commission invited to Ireland
- Encourage our researchers to travel to meetings, for information days and to participate at conferences, workshops etc.
- Close interaction with Research Institutes to develop FP7 strategies





Financial Assistance in Ireland for FP7

- Coordinator preparation of proposal up to €12,500
- Other Assistance from Enterprise Ireland
 - Travel Support
 - Feasibility Studies





Irish networking activities

- Meetings with the Commission
- Introductions for Irish researchers
- Attend information events
- Meetings with the Cabinet
- Information days for Irish researchers, research officers, VPs of research, visiting scientists etc.
- Create itineraries for Irish researchers
- Partner searching





EUROPE 2020 strategy and the Innovation Union

- Innovation Union one of 7 flagships
- A cornerstone of Europe 2020 strategy
- Three aspects:
- Globalisation of knowledge production and innovation capacities
- Impact of the **crisis** on public and private finance, survival of innovative SMEs
- Major challenges to address with reduced means
- → Innovation emergency!


Networking in Brussels IGLO
