


European Parliament: MEPs per country

NEW RULES – Election of Commission President

Under the new rules of the Lisbon Treaty, EU government leaders, who will propose a candidate for the post of the future **Commission President**, must take into account the elections to the European

Parliament.



Spitzenkandidaten ...a new process

- Parliament felt they had the right to propose candidates and each group except the ECR did just that
- Some Member States fought against this most notably the UK and insisted it was the sole decision of the European Council
- In the end the Council agreed on Jean-Claude Junker with the UK and Hungary voting against
- Mr Junker was the candidate of the EPP who won the most seats in the election

NEW PRESIDENT OF THE EUROPEAN COMMISSION (5 year term)

Jean-Claude Juncker

Confirmed by Parliament with 422 votes to 170 against in July 2014



Three Year Plan

- Jean-Claude Juncker stated that he will prepare a 3 year program in which the EU will successfully gather €300bn in investments & create jobs
- He intends on introducing:
- Minimum wage in all member states
- Reduce red-tape for SME's
- Ensure Europe's energy security

Commission Candidates

- Process of negotiation with Member States then began on who they would nominate as their Commissioner and what portfolios Juncker would allocate them
- September and October will see Parliament
 Committees question each of the 27 candidates
- The whole of his Commission will be subject to a confirmatory vote by the Parliament at the end of October
- Due to take up post with his entire Commission on 1st November 2014

President of the European Council

- Polish Prime Minister Donald Tusk chosen by European
 Council to replace Herman Van Rompuy for a once renewable
 2 and a half year term
- Due to take up post on 1st November 2014 alongside the new Juncker Commission

Jean-Claude Juncker

- "SMEs are the backbone of our economy creating more than 85% of new jobs in Europe"
- We must make use of public funds at Union level to stimulate private investment
- It is crucial that we have smarter investment, more focus, less regulation and more flexibility
- The growth of jobs will only return if we create the right regulatory environment

The Importance of SMEs in our Economy

- 300,000 SMEs in Ireland & Northern Ireland employing 1.4 million
- Represents 70% of our total work force
- SMEs represent 99.9 % of all enterprises in Northern Ireland

Support for SMEs in the EU?

There is more than **20 million** SMEs in the EU that represent **99%** of businesses

The European Commission aims to promote entrepreneurship and improve the business environment for SMEs to allow them to realise their full potential in today's global economy



European Sustainable Competitiveness programme 2007-2013

- Promoted investment in research & technological development and encourage enterprise and entrepreneurship
- The programme drew its funding from the European Regional Development Fund and the total programme value for Northern Ireland was approximately £470m
- Around 55% of these funds where designated to Invest Northern Ireland programmes

Gateways to Growth Project

Main objective:

 provide support for European SMEs interested in expanding their business on the Japanese or Korean market with one-week business missions assisting EU companies to export to Korea & Japan

- ▶ 70% of SME's surveyed as part of the Gateways to Growth Programme have a better attitude to doing business on a cross border basis, according to figures published earlier this year in February by Northern Ireland Chamber of Commerce
- ▶ 68% of participants reported an increase in turnover in the last six months while 78% reported an increased confidence in their ability to export.

The assistance schemes have been divided into the following four categories:

- 1) Thematic Funding Opportunities
- 2) Structural Funds
- 3) Financial Instruments
- 4) Support for the Internationalisation for SMEs




